Terms of Qualification / Mandatory Provisions:

1. Competent Aviation Authority have the right to gain access into partners/sub-contractors/suppliers premises in order to carry out inspection/investigations as required by applicable Aviation Regulation,
2. JBSL qualified suppliers owning a Supplier Qualification Certificate (JBSL Form 2349), are required to stick to the terms of qualification pointed out in the relevant Supplier Qualification Certificate. Mentioned terms of qualification includes but are not limited to the fulfillment of the documentation management conditions pointed out by the Supplier Qualification Certificate.
3. With reference to Production Organization subcontractor (Part 21G), the subcontractor is required delivering to JBSL all original Production Records defined in the Qualification Certificate. Moreover, the subcontractor is also required to keep copy of the same documentation (production records) for a period of three years starting from the production of such documentation or from the date when relevant work activity has been finalized, basing this choice on the longer time of archiving.
4. Any deviation from the approved Design Data occurred in Production, at subcontractor premises, must be communicated, as soon as possible, to Jet Aviation, preferably by means and times defined by Jet Aviation requirements (ref. JBSL –PR-0387, chapter 5.7).
5. Any failures, malfunction, defects or other occurrences which cause or might cause adverse effects on the continuing airworthiness of the product, part or appliance provided by the supplier, must be communicated to Jet Aviation by means and times defined by Jet Aviation requirements (ref. JBSL –PR-0387, chapter 5.7),
6. Subcontractor is required to report to Jet Aviation, by means and times defined by Jet Aviation requirements (ref. JBSL –PR-0387, chapter 5.7), any change potentially affecting the product and/or the service provided to Jet Aviation. Mentioned changes includes but are not limited to the following:
 - a. Changes of Jet Aviation qualified personnel,
 - b. Change of Jet Aviation qualified facility,
 - c. Change on Jet Aviation qualified manufacturing processes,
 - d. Change on Quality processes affecting the product/service provided to Jet Aviation,
 - e. Use of subcontractors for activities relevant to product/service provided to Jet Aviation, when such subcontractors have been not previously accepted by Jet Aviation (new subcontractors),
 - f. Changes in processes used to control subcontractor already accepted by Jet Aviation,
 - g. Change on production capacity.
7. Suppliers have the obligation to ask to Jet Aviation any document, which is not in his possession, containing explanation to fulfill to above requirements
