## **PURPOSE**

The purpose of this Policy is to demonstrate the commitment of Littelfuse, Inc. to the long-term value of a robust sustainability strategy, that is communicated through the annual publication of the Littelfuse Sustainability Report, and other sustainability disclosure initiatives.

### **SCOPE**

This Policy applies globally to all Littelfuse companies, including all directly and indirectly, owned subsidiaries and affiliates under the operational control of Littelfuse, Inc. (collectively, the "Company"). We expect all our employees to be aware of this Policy.

#### **RESPONSIBILITY**

The Sustainability Steering Committee, under the direction of the Chief Legal Officer, shall be responsible for establishing the Company's Sustainability strategy, goals and targets, and for maintaining this Policy and providing periodic training. The Sustainability Steering Committee provides regular sustainability program updates to the Chief Executive Officer, Chief Financial Officer, Chief Legal Officer, and Chief Human Resources Officer.

The Nominating and Governance Committee of the Board of Directors provides oversight of the Company's sustainability program.

#### POLICY

Littelfuse has identified its key stakeholders, including customers, employees, investors, and the communities where we live and work. Through our engagement efforts with these key stakeholders, we have identified strategic focus areas that align with our overall business strategy. These strategic focus areas, including our goals and metrics, are approved by the senior leadership team, and our progress towards these goals is communicated to our key stakeholders through our annual Sustainability Report, which is approved by the Nominating and Governance Committee.

The identification of these strategic focus areas will be reviewed and updated periodically through internal and external materiality assessments.

#### PROCEDURE

To ensure that we communicate our sustainability initiatives in a transparent and accurate manner to all stakeholders, Littelfuse has committed to provide disclosure on each of the material topics listed below, not less than annually.
